The City Manager Representatives, Affiliate Members and Executive Director sit as non-voting, ex-officio members.

- **Legislative and Regulatory Committee Chair**, two-year term to commence in December 2024 and complete in December 2026 (*All Member Cities are eligible*)
- **Large City Rep. #1**, two-year term to commence in December 2024 and complete in December 2026 (*Eligible Member Cities: Anaheim, Irvine, Santa Ana, Huntington Beach, Garden Grove, Orange, Costa Mesa, Mission Viejo*)
- **Large City Rep. #3**, two-year term to commence in December 2024 and complete in December 2026 (*Eligible Member Cities: Anaheim, Irvine, Santa Ana, Huntington Beach, Garden Grove, Orange, Costa Mesa, Mission Viejo*)
- **2nd District Rep.**, two-year term to commence in December 2024 and complete in December 2026 (*Eligible Member Cities: Anaheim, Santa Ana, Garden Grove, Orange*)
- **4th District Rep.**, two-year term to commence December 2024 and complete in December 2026 (*Eligible Member Cities: Stanton, Placentia, Buena Park, Anaheim*)
