Urgent Opposition to Budget Cuts Threatening REAP 2.0 Reforms February 27th, 2024

Dear Members,

I write to you with a matter of grave concern and urgency. Our efforts to advance crucial reforms under the Regional Early Action Planning (REAP) 2.0 program are under threat due to proposed budget cuts. It is imperative that we act swiftly and decisively to oppose these cuts and safeguard the progress our cities have made to date in working to meet housing requirements and regulations.

We urge you to stress the importance of REAP 2.0 reforms and the detrimental impact that budget cuts would have on our ability to address housing challenges effectively by supporting legislation that opposes such budget cuts. The REAP 2.0 reforms are vital for promoting transparency, accountability, and equitable distribution of housing resources across our region. This proposal to cut REAP 2.0 funding would devastate Orange County jurisdictions and numerous other SCAG-region cities, counties, transportation agencies, and tribal governments.

AB 2485 (Carrillo): This bill, introduced as a spot bill by SCAG, aims to increase transparency around the data sources, analyses, and methodology used by the Department of Housing and Community Development (HCD) to finalize a region's Regional Housing Needs Assessment (RHNA) determination.
