A PDIP representative will visit each of your school sites to determine which energy-efficiency upgrades qualify for professional, no-cost installation.

By participating in this program, these energy-efficient upgrades may help your school district save energy and could lower your energy costs.

# Receive no-cost energy upgrades

SoCalGas customers categorized as public education facilities, K-12 schools, local government buildings, and federal government buildings qualify to participate in this no-cost energy-efficiency program. Each site must have an active non-residential SoCalGas account in good standing.

A Public Direct Install Program (PDIP) representative will be available to help you with any specific questions regarding the program.

### Natural gas equipment rebates and financing

A PDIP representative is available to discuss eligible customers rebates on natural gas equipment upgrades along with Zero-Percent On-Bill Financing.

- Natural Gas Storage Water Heater
- Natural Gas Tankless Water Heater
- High-Efficiency Natural Gas Furnace
- Efficiency Infrared Patio Heaters
- Solar Thermal Water Heating

Equipment installations require a copay which can be paid through Zero-Percent On-Bill Financing (OBF).

#### What is OBF?

OBF allows eligible customers to finance on energy-efficient projects. The loan is conveniently repaid through your utility bill. Other key benefits of the program include:

- No prepayment penalty
- May help lower monthly natural gas usage
- No origination fee
