ELIGIBILITY REQUIREMENT

The LPS program serves Local government, Federal government, K-12 Education, Special districts, Public-Owned utilities; Local government - Cities, Counties, County hospitals, Health districts, Transportation, Public housing, Water/Wastewater (not statewide), Correctional facilities (not statewide). These customers must have an active SoCalGas account and use equal to or greater than 50,000 therms annually.

ABOUT LPS REPRESENTATIVES

A LPS representative will provide the following assistance to help Public sector entities with their Zero Net Energy goals:

- Conduct comprehensive building and whole facility energy audits to determine opportunities for retrofits
- Develop prioritized list of savings opportunities and create energy savings plan and roadmap

- Conduct energy savings calculations
